



#### EMERGENCY TEMPORARY LICENSE IN RESPONSE TO COVID-19 FOR LPNs NOT CURRENTLY IN PRACTICE

An emergency temporary license is available for practical nurses who wish to return to nursing practice during the COVID-19 pandemic. The emergency temporary license is only for the purpose of returning to practice to assist in response to COVID-19 and is not for those who intend to obtain ongoing employment in NL. 

CLPNNL has prepared a number of Frequently Asked Questions (FAQs) that you will find by visiting the practice and policy section on our website (<u>CLPNNL Practice and Policy</u>).

- I am a self-employed LPN and I provide care in a client's home. Can I continue to do this during the COVID-19 Public Health Emergency?
- I am concerned about the wellbeing of my patients as well as my family. How do I balance those obligations?
- Where do I go to find the most current and reliable information during COVID-19?
- Due to COVID-19 I am being told I must float to an area I am not familiar with and have not practiced in before. What should I consider?
- What do I do if I am concerned about available personal protective equipment (PPE)?
- I have taken a temporary license in response to COVID-19 and will be returning to practice. How will I know what I can and cannot do?
- How do I obtain a license to practice to assist during COVID-19?
- I am obtaining a temporary license to assist during COVID-19, but where do I go to obtain employment?

When seeking information on COVID-19, ensure that you have the most reliable and up to date information. The CLPNNL website (www.clpnnl.ca) provides links to several important sources, such as provincial and federal governments and other organizations.

#### **REMINDER: KEEP YOUR INFORMATION UP-TO-DATE!**

Under the College of Licensed Practical Nurses of Newfoundland and Labrador By-laws (2014) Section 34 - Accuracy of Personal Information, all LPNs are required to keep their information on file with CLPNNL up-to-date. This includes:

- Name change (copy of legal documentation required)
- Mailing address
- Email address
- Employment information
- Phone numbers



If any of the above information has recently changed, please contact the CLPNNL by phone (709-579-3843) or email (<u>info@clpnnl.ca</u>) to update your file.
